

## Media Release: Response to the BC Select Standing Committee on Health illicit drug toxicity and overdose crisis report recommendations

November 1, 2022

Vancouver, BC - Today's release of the <u>Closing Gaps</u>, <u>Reducing Barriers</u>: <u>Expanding the Response to the Toxic Drug and Overdose Crisis</u> report by the Select Standing Committee on Health marked a decisive step taken by the Provincial Government toward a more effective plan to combat the deadly and ongoing toxic drug crisis in BC.

We are specifically heartened by the Committee's consideration of the following:

- Engaging crisis lines and crisis support services to provide wraparound supports such as follow-up calls after a toxic drug-related event and at discharge from detox and recovery programs; and
- Supporting the recommendation of the Special Committee on Reforming the Police Act to integrate mental health within 911 call options, taking a health-first approach to addiction and toxic drug crisis.

The Committee recommends improving trauma-informed mental health care, providing stable funding to non-profits, and improving public awareness, which relate to the work of crisis lines across BC.

"Crisis lines across BC are thrilled to see recommendations that integrate our province-wide, 24 hours a day services into the continuum of care for folks suffering from the toxic drug and overdose crisis and addictions," says Stacy Ashton, chairperson of the BC Crisis Line Network. "Crisis is layered and needs the individualized, collaborative, trauma-informed approach we use to help people find their own way through."

The BC Crisis Line Network comprises ten regional crisis centres across BC, collectively answering 1800SUICIDE (1-800-784-2433) and 310Mental Health Support (310-6789). The Network operates 24 hours a day, seven days a week and provides lifesaving crisis intervention, suicide risk assessment, and strengths-based collaborative safety planning and follow-up to vulnerable British Columbians.

The BC Crisis Line Network applauds the Select Standing Committee on Health for making these recommendations that will help protect and care for British Columbians and looks forward to working with the Provincial Government and all other stakeholders to make these recommendations a reality.
